RESOLUTION NO. 458-2019

DECLARING MUNICIPAL ORDINANCE NO. 2019-04 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR THE ABOLITION AND CREATION OF SOME OF THE POSITIONS IN THE PLANTILLA OF THE MUNICIPALITY OF BINALONAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2019-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall comply with the observations of the Local Finance Committee stated in its opinion dated 24 July 2019, hereunder quoted:

1. The position title of Human Resource Management Officer III, Salary Grade 18 should be changed to Administrative Officer V, Salary Grade 18 to conform with the provisions of Budget Circular No. 2004-3 dated March 6, 2004 entitled “Conversion of Positions Performing Staff/Non-Technical Functions”;


2. The position title of DRRM Staff 1, 2 and 3, Salary Grade 8 should be changed to Local Disaster Risk Reduction Management Assistant pursuant to the provisions of NDRRMC-DILG-DBM-CSC Joint Memorandum Circular No. 2014-1 dated April 4, 2014;
3. The position of Municipal Economic and Investments Promotion Officer (MEIPO) is not included in the Index of Occupational Services, Position Titles and Salary Grades for local government units.

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
