#### APPROVING RESOLUTION NO. 20-027A OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF TWO MILLION ONE HUNDRED FORTY SIX THOUSAND SEVEN HUNDRED EIGHTY TWO PESOS & 1/100 (P2,146,782.01)"

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 20-027A to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Laoac, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Annual Investment Program No. 2 through MDC Resolution No. 2020-02 dated March 17, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan through Resolution No. 20-027A dated March 23, 2020;

**WHEREAS**, the Supplemental Annual Investment Program No. 2 of the municipality with an investment requirement amounting to P2,146,782.01 covers the programs, projects and activities to address emergency response measures to COVID-19 pandemic;

**WHEREAS**, the Sangguniang Bayan enacted Supplemental Budget No. 1, S-2020 thru Appropriation Ordinance No. 2020-001 to support the implementation of the said Supplemental Annual Investment Program No. 2;
