RESOLUTION NO. 476-2021

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CY 2021 OF BAUTISTA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P24,000,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2021 involving total appropriations of P24,000,000.00 which was approved on April 26, 2021 through Appropriation Ordinance No. 1, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R. A. No. 7160 and Article 417 (a) of its Implementing Rules and Regulations as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017, dated March 8, 2007;
3. That all procurement to be undertaken shall be subject to the pertinent provisions of RA No. 9184 or the Government Procurement Reform Act and its Implementing Rules and Regulations; *and*
4. That the purchase of rescue vehicle shall be in accordance with the provisions of DILG Memorandum Circular No. 2021-04 dated January 18, 2021.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


