APPROVING MUNICIPAL RESOLUTION NO. 185-2020 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 03 OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY-2020"

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its SB Resolution No. 185-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Natividad, Pangasinan had identified items in their Supplemental Investment Program for CY 2020 through MDC Executive Committee Resolution No. 05-2020;

WHEREAS, the Supplemental Investment Program (SIP) with a total investment requirement of P3,024,919.96 covers fund augmentation for the Personal Services (granting of Service Recognition Incentive to municipal officials and employees) and Maintenance and Other Operating Expenses of some municipal offices and implementation of various infrastructure projects of the LGU;

WHEREAS, the LGU enacted Supplemental Budget No. 3 through Appropriation Ordinance No. 04-2020 on December 21, 202 in the amount of P3,024,919.96 to support the funding requirement of this Supplemental Investment Program No. 3, CY 2020, but was remanded to the concerned LGU because of infirmities;

WHEREAS, on March 23, 2021, the Sangguniang Bayan of Natividad, Pangasinan passed and approved Appropriation Ordinance No. 01-2021 enacting Supplemental Budget No. 3, CY 2020 in the same amount, to support the Supplemental Investment Program (SIP) No. 03, CY 2020. The Municipal Mayor vetoed new items of appropriation in the Appropriation Ordinance on the grounds that said item is not included in the Supplemental Budget No. 3 CY 2020 and in the approved Municipal Development Council Resolution submitted by the LCE but the Sangguniang Bayan did not override it;

WHEREAS, the Sangguniang Panlawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Natividad, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 185-2020 of the Sangguniang Bayan of Natividad, Pangasinan, entitled "Approving the Supplemental Annual Investment Program (AIP) No. 03 of the Municipality of Natividad, Province of Pangasinan for CY 2020";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Natividad, Pangasinan, for its information and guidance.
