APPROVING RESOLUTION NO. 168, S-2017 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE REALIGNMENT OF DEVELOPMENT PROJECTS IN THE 20% DEVELOPMENT FUND OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 168, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the proposal for realignment emanates from the Local Development Council and was endorsed to the Sangguniang Bayan on November 21, 2017 thru MDC Resolution No. 04, S-2017 and this favorably acted upon by the Sangguniang Bayan on November 28, 2017 thru SB Resolution No. 168, S-2017;

WHEREAS, the amount of P8,042,153.45, which is earmarked for realignment came from balances of 20% development fund in CYs 2015, 2016 and 2017;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
