APPROVING RESOLUTION NO. 2019-92 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2019-02 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2019-92 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binalonan, Pangasinan has formulated the municipality's Supplemental Investment Program No. 2 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 3, S-2019 dated May 22, 2019. The Sangguniang approved the Supplemental Investment Program No. 2 on May 23, 2019 thru Resolution No. 2019-92. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality with an investment requirement amounting to P39,936,136.82 covers fund augmentation for the Personal Services, maintenance and other operating expenses of some offices and implementation of development projects in the municipality;
