#### **PROVINCIAL RESOLUTION NO. 487-2021**

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO, III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPHINE CHARITY SWEEPSTAKE OFFICE (PCSO) FOR THE GRANT OF LOTTO/STL CHARITY FUND SHARE AND CALAMITY ASSISTANCE TO THE PROVINCE OF PANGASINAN

**WHEREAS,** RA 1169 mandates the PCSO to raise and provide funds for health programs, medical assistance and services, and charities of national character, through the conduct of sweepstakes, races, lotteries and other similar activities;

WHEREAS, one of the main thrusts of the present administration is to ensure the provision and availability of medical facilities for emergency services, health programs and social services, and provide appropriate forms of assistance to areas and persons affected by calamities and disasters;

WHEREAS, the PCSO recognizing the role of LGUs as its partners in raising revenues within their jurisdiction would like to support them by sharing them a portion of the charity fund generated from the sales of Lotto and STL as well as providing them Calamity Assistance which can be used for the needed medical and health services of their constituents;

WHEREAS, the grant of Lotto/STL Charity Fund Share shall be utilized by the Province of Pangasinan for health programs, medical assistance and charitable services including but not limited to medical/dental missions, medicine donation, hospitalization assistance, procurement of medical supplies/equipment or milk feeding/nutrition program;

WHEREAS, the grant also of Calamity Assistance to the Province shall be used for food necessities of, and feeding projects for, displaced families in evacuation centers, procurement of medicines and/or medical supplies necessary for disease prevention and/or treatment, temporary shelters, blankets, mattresses, or other applicable forms of assistance or services;
