APPROVING RESOLUTION NO. 20-51 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN FOR CY 2020”

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Resolution No. 20-51 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sta. Maria, Pangasinan has formulated, adopted and endorsed the municipality’s Supplemental Annual Investment Program No. 2 through MDC Resolution No. 2020-02 dated April 14, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on April 17, 2020 through Resolution No. 20-51. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 2 has an investment requirement amounting to P9,230,214.00 covers programs/projects/activities to address emergency response measures to COVID-19. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan to Heal as One Act);


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
