APPROVING RESOLUTION NO. 78-2020 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 01-2020 OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY 2020"

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Resolution No. 78-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Natividad, Pangasinan has identified programs/projects/activities to address emergency response measures to COVID-19. This is embodied in the municipality's Supplemental Investment Program No. 01-2020 which was endorsed through MDC Resolution No. 02-2020 dated April 14, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan May 4, 2020 through Resolution No. 78-2020. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 01-2020 has an investment requirement amounting to P8,885,656.00 which will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan to Heal as One Act);
