## **PROVINCIAL RESOLUTION NO. 513-2021**

### **APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2021**

**WHEREAS**, presented for consideration is the Supplemental Investment Program No. 4 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC Execom Resolution No. 10-21;

**WHEREAS**, Supplemental Investment Program No. 4 contains other priority programs, projects and activities that are not included in the approved 2021 Annual/Supplemental Investment Programs of the Province of Pangasinan;

**WHEREAS**, Supplemental Investment Program No. 4 contains the following: Purchase of Various Hospital Equipment; Purchase of Vehicles; Provision of Financial Assistance to Individual in Crisis, Sports Programs for the PWD, Displaced Local Workers and Overseas Filipino Workers due to pandemic; Provision of Provincial Livelihood Assistance, Upgrading/Construction of Various Roads; and Construction of Provincial Buildings;

**WHEREAS**, the said programs, projects and activities are proposed for funding from the Local Government Support Fund – Financial Assistance (LGSF-FA) to Local Government Units in Republic Act No. 11518 or the 2021 General Appropriations Act (GAA) and are in accordance with Local Budget Circular No. 131, dated January 8, 2021 of the Department of Budget and Management;

**WHEREAS**, also embodied in this Supplemental Investment Program No. 4 is the Pangasinan Tara Na Online Tourist Registration System (OTRS) – Provision of Equipment and Technical Assistance to LGUs, as sub project under the Strengthening ICT Capability in Tourism in the Annual Investment Program 2021 of the Provincial Tourism and Cultural Affairs Office and funded under Other Special Purpose Appropriations (Non-Office) – Annual Budget 2021;

**WHEREAS**, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


**WHEREAS**, after careful study of the said Program, this august Body finds it to be in order;
