RESOLUTION NO. 514-2020

APPROVING RESOLUTION NO. 141, S-2020 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2020 OF THE LOCAL GOVERNMENT OF UMINGAN STATING THE PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) TO BE FUNDED BY THE INCREASE OF THE INTERNAL REVENUE ALLOTMENT (IRA) AMOUNTING TO TEN MILLION FIVE HUNDRED FIFTY TWO THOUSAND AND FORTY TWO PESOS (P10,552,042.00)”

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Resolution No. 141, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Umingan, Pangasinan has identified programs/projects/activities to be funded by their 2020 IRA increase of their IRA. This is embodied in the municipality’s Supplemental Annual Investment Program which was endorsed through MDC Resolution No. 1, S-2020 dated March 3, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan March 16, 2020 through Resolution No. 141, S-2020. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program with an investment requirement amounting to P10,552,042.00 covers implementation of fund augmentation for Personal Services, Maintenance and Other Operating Expenses of the Executive and Legislative department, and implementation of development and the disaster risk reduction management program of the municipality;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
