APPROVING RESOLUTION NO. 85-2019 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 01 CALENDAR YEAR 2019 OF THE MUNICIPALITY OF ROSALES, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 85-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Rosales, Pangasinan has formulated the municipality's Supplemental Investment Program No. 01 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 0725, S-2019 dated July 25, 2019. The Sangguniang Bayan approved the Supplemental Investment Program on July 26, 2019 thru Resolution No. 85-2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program of the municipality with an investment requirement of P2,028,188.90 covers the granting of Performance-Based Bonus for CY 2017 to all qualified municipal officials and employees of the municipality;
