APPROVING RESOLUTION NO. 11-A, S-2019 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPAL SUPPLEMENTAL BUDGET NO. 2, S-2019 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 11-A, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Quintin, Pangasinan has formulated the municipality's Supplemental Investment Program for Calendar Year 2019 and endorsed thru MDC Resolution No. 2, S-2019 dated July 1, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved the Supplemental Investment Program on July 29, 2019 thru Resolution No. 11-A, S-2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program of the municipality with an investment requirement amounting to P2,172,693.68 covers the procurement of one-unit dump truck, repair and maintenance of equipment and procurement of various medicines and insecticides;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
