APPROVING RESOLUTION NO. 2020-61 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE REVISED ANNUAL INVESTMENT PROGRAM FOR CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-61 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Mangaldan, Pangasinan prepared the Revised Annual Investment Program (AIP) for CY 2020. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 01, S-2020 dated March 3, 2020 and was approved by the Sangguniang Bayan through SB Resolution No. 2020-61 dated March 31, 2020;

WHEREAS, the LGU's AIP, CY 2020 was revised to include additional projects and activities to be funded from the Unexpended Balances of Municipal Disaster Risk Reduction and Management Fund for CY 2019 and prior years as endorsed by the Municipal Disaster Risk Reduction and Management Council through MDRRMC Resolution No. 1-2020 dated February 20, 2020 to the Municipal Development Council and Sangguniang Bayan for approval;

WHEREAS, the preparation of the Revised AIP is in pursuance to Sections 6.4 and 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
