RESOLUTION NO. 528-2022

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF SAN MANUEL, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P283,385,269.45, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P283,385,269.45 which was enacted on December 15, 2021 through Appropriation Ordinance No. 05, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the full implementation of the Third Tranche Compensation Adjustment for all municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 143 dated January 3, 2022;

2. That the position title of General Services Officer A SG 16 under the Office of the Mayor should be changed to Senior Administrative Assistant IV SG 16 to conform with Local Budget Circular No. 137 dated July 13, 2021 (Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition);
3. That the salary grade allocation of Librarian II should be adjusted from SG 14 to SG 15 to conform with Local Budget Circular No. 2009-92 dated September 3, 2009 and Local Budget Circular No. 137 dated July 13, 2021;
4. That the position title Ambulance Driver SG 8 is not among the positions authorized in Local Government Units. Budget Circular No. 2004-3 dated March 6, 2004 provides the following position titles for Driver:

Administrative Aide I (Driver I) - SG 3
Administrative Aide II (Driver II) - SG 4
5. That the grant of step increment to elective officials and municipal employees shall be in accordance with the CSC-DBM Joint Memorandum No. 01, series of 2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, Series of 2016 dated January 27, 2016;
6. That the projects under the 20% of the Annual National Tax Allotment for Development Projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020. Re: Revised Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects;
7. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the Department of Budget and Management - National Disaster Risk Reduction and Management Council - Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);

8. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
9. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
10. That the appropriation for Public Affairs Fund shall be spent solely for public purposes and no amount shall be applied for religious or private purposes pursuant to Sections 305 (b) and 335 of R.A. No. 7160, and shall be broken down into appropriate objects of expenditures, as may be applicable, in accordance with the Revised Chart of Accounts for LGUs under COA Circular 2015-009 dated December 1, 2015; and
11. That the appropriation for devolved functions and services in FY 2022 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with Devolution Transition Plan of the Municipality.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Annual Budget for Calendar Year 2022 of San Manuel, Pangasinan;




