APPROVING RESOLUTION NO. 48-2018 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 48-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Urbiztondo, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Local Development Council to the Sangguniang Bayan thru MDC Resolution No. 02, S-2018 dated October 8, 2018 and was favorably acted upon by the Sangguniang Bayan thru SB Resolution No. 48-2018 dated October 29, 2018;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint

Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Urbiztondo, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, d) Local Climate Change Action Plan, e) Peace and Order Plan and f) PPAs to combat AIDS and g) Activities in pursuance of the objectives of GAD, Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities of the LGU;

WHEREAS, the proposed AIP of Urbiztondo for CY 2019 has a total investment requirement of P958,863,251.30. Funding support for the implementation of said AIP is embodied in their 2019 proposed Annual Budget in the amount of P142,435,314.00 which was passed and approved by their Sangguniang Bayan on October 29, 2018 through Appropriation Ordinance No. 1-2018 and from external fund sources in the amount of P816,427,251.30;

**WHEREAS,** this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P128,675,314.00) which is equivalent to P25,735,062.80 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund conform with the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P7,121,765.70) is in conformity to Section 21 of RA 10121. The programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P4,985,235.99 conform to NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of the Interior and Local Government (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). However, it is respectfully recommended that the LGU should comply with the attached recommendation of the OCD-RO1 as per their review of their LDRRMP;

**WHEREAS**, the LGU of Urbiztondo had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
