APPROVING RESOLUTION NO. 19, S-2019 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN AND OTHER ACTIVITIES RELATED TO THE FY 2016 COLLECTION OF BURLEY AND NATIVE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT NO. 8240, AS AMENDED BY REPUBLIC ACT NO. 10351 IN THE AMOUNT OF TWENTY SEVEN MILLION ONE HUNDRED NINETY-SIX THOUSAND SIXTY-NINE PESOS ((P27,196,069.00))”

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 19, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Villasis, Pangasinan formulated the municipality’s Supplemental Annual Investment Program covering projects to be funded from LGU’s share from FY 2016 collection of Burley Tobacco Excise Tax in the amount of P27,196,069.00. This was endorsed through MDC Resolution No. 01-2019 dated August 5, 2019 and was subsequently approved by the Sangguniang Bayan through Resolution No. 19, S-2019 dated August 30, 2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the identified projects conform with Local Budget Memorandum No. 79 dated June 14, 2019 (Guidelines on the Release and Utilization of the Shares of Local Government Units from the FY 2016 Collections of Excise Tax on Locally Manufactured Virginia-Typed Cigarettes under RA No. 7171 and Burley and Native Tobacco Excise Tax pursuant to RA 8240, as amended by RA 10351, chargeable against the Allocation of Local Government Units under the FY 2018 General Appropriations Act, RA 10964, Continuing Appropriations);


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
