RESOLUTION NO. 533-2022

DECLARING ORDINANCE NO. 2021-05 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE FOR THE CREATION OF TWO (2) UTILITY WORKER II, SALARY GRADE-3, PERMANENT POSITION UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICE AND OFFICE OF THE MUNICIPAL MAYOR OF SAN MANUEL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Ordinance No. 2021-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, however, the position title of Utility Worker II should be changed to Administrative Aide III-Salary Grade 3 to conform with Civil Service Commission Memorandum Circular No. 10, S. 2005;




