DECLARING ORDINANCE NO. 2021-07 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE FOR THE CREATION OF THE POSITION OF ADMINISTRATIVE ASSISTANT II (CLERK IV), SALARY GRADE – 8 UNDER THE OFFICE OF THE MUNICIPAL MAYOR IN THE MUNICIPALITY OF SAN MANUEL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT




