## **RESOLUTION NO. 536-2022**

**DECLARING ORDINANCE NO. 2021-17 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE AND THE POSITION OF MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICER (MENRO) SALARY GRADE-24, PERMANENT POSITION OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN AND APPROPRIATING FUND THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**




