DECLARING **ORDINANCE** NO. 2021-17 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE AND POSITION OF MUNICIPAL ENVIRONMENT NATURAL RESOURCES OFFICER (MENRO) SALARY GRADE-24, PERMANENT POSITION OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN AND APPROPRIATING THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
