APPROVING RESOLUTION NO. 2021-134 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3, CY 2021 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2021-134 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of Mangaldan, Pangasinan prepared the LGU's Supplemental Investment Program No. 3 for CY 2021. This was endorsed to the Sangguniang Bayan of Mangaldan by the Council through MDC Resolution No. 3, Series of 2021 dated April 23, 2021;

WHEREAS, said Supplemental AIP which has a total investment requirement of P32,184,000 .00 covers augmentation funds for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay and implementation of the priority infrastructure projects of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the LGU surplus from CY 2020 and prior years, as embodied in the LGU's Supplemental Budget No. 3, for CY 2021 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2021-06 dated May 21, 2021;
