APPROVING RESOLUTION NO. 2022-655 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE MUNICIPALITY'S REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2022"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its SB Resolution No. 2022-655 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Section 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Balungao, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2022 on March 15, 2022 thru MDC Resolution No. 2022-02;
2. The 2022 AIP of the Municipality of Balungao was revised to integrate the Supplemental Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) prepared and endorsed by the MDRRM Council thru MDRRM Resolution No. 2022-01 on March 11, 2022.

The Supplemental LDRRMFIP includes COVID-19 related program and the preparation of CDRA Enhanced CDP of the municipality which will be funded from the municipality's unexpended balances of their LDRRMF CYs 2020 and 2021 in the amount of Php3,051,013.25;

- This in accordance to Item 6.5 the NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013 (The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP).




