APPROVING RESOLUTION NO. 22-028 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FOR CALENDAR YEAR 2022 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN”

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its SP Resolution No. 22-028 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution with the following findings:

1. The City Development Council – Executive Committee of San Carlos City, Pangasinan prepared the Supplemental Investment Program (SIP) No. 2, CY 2022. This was endorsed by the Council, through CDC Resolution No. 02-22 (Series of 2022) dated March 3, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental Investment Program (SIP), which has a total investment requirement of ₱10,500,000.00, covers fund augmentation for the Personal Services, (implementation of the Third Tranche of Salary Increase of all city officials and employees and the provision of funds for the Monetization of Leave Credits to qualified personnel of the City Government of San Carlos); and

- Funding for the SIP will be sourced from the Savings/Surplus of the LGU as embodied in the LGU's Supplemental Budget No. 02-22, FY 2022, which was approved by their Sangguniang Panlungsod through Appropriation Ordinance No. 22-04, dated March 14, 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of San Carlos, Pangasinan;
