APPROVING SB RESOLUTION NO. 20, S-2019 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 CY 2019 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 20, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2019 with a total investment requirement of P7,017,415.41. This was endorsed to the Sangguniang Bayan for approval on March 21, 2019 thru MDC Resolution No. 2019-01 and was favorably acted upon by the Sangguniang Bayan on July 16, 2019 thru SB Resolution No. 20, S-2019;

WHEREAS, the Supplemental Investment Program No. 1 for CY 2019 of the municipality covers the fund augmentation for the Personal Services of all municipal offices and Maintenance and Other Operating Expenses and Capital Outlay of the Executive Services;


