APPROVING RESOLUTION NO. 09-19-48 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) SERIES OF 2019 OF THE LGU OF MABINI, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 09-19-48 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Mabini, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2019. This was endorsed to the Sangguniang Bayan for approval on September 6, 2019 thru MDC Executive Committee Resolution No. 001, S-2019 and was favorably acted upon by the Sangguniang Bayan on September 9, 2019 thru SB Resolution No. 09-19-48;

WHEREAS, the Supplemental Investment Program No. 1 for CY 2019 of the municipality covers the fund augmentation for the Personal Services, Capital Outlay and Maintenance and Other Operating Expenses of various municipal offices and implementation of development projects and disaster risk reduction and management projects of the municipality;
