APPROVING RESOLUTION NO. 220, S-2019 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CY 2019 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 220, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2019. This was endorsed to the Sangguniang Bayan for approval on August 22, 2019 thru MDC Resolution No. 4, S-2019 and was favorably acted upon by the Sangguniang Bayan on September 12, 2019 thru SB Resolution No. 220, S-2019;

WHEREAS, the Supplemental Investment Program No. 2 for CY 2019 of the municipality covers the fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various municipal offices and payment of loan for the implementation of development project;

WHEREAS, the payment of loan for the implementation of development project proposed to be funded by realigned 20% development fund is in accordance with DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled “Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects”;

WHEREAS, the proposed Supplemental Investment Program No. 2 has an investment requirement of P16,629,089.60. Funding support for the implementation of this Supplemental Investment Program is embodied in their proposed Supplemental Budget No. 2, CY 2019 which was approved and enacted by their Sangguniang Bayan on September 12, 2019 thru Appropriation Ordinance No. 2;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


