APPROVING RESOLUTION NO. 034-2019 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 FOR CY 2019 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 034-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Labrador, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2019. This was endorsed to the Sangguniang Bayan for approval on August 20, 2019 thru MDC Resolution No. 0015, S-2019 and was favorably acted upon by the Sangguniang Bayan on September 2, 2019 thru SB Resolution No. 034-2019;

WHEREAS, the Supplemental Investment Program No. 1 for CY 2019 of the municipality covers the fund augmentation for the Maintenance and Other Operating Expenses of some municipal offices and implementation of infrastructure projects;
