PROVINCIAL RESOLUTION NO. 573-2021

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH FOR THE IMPLEMENTATION OF THE INTEGRATED HOSPITAL OPERATIONS AND MANAGEMENT INFORMATION SYSTEM (iHOMIS) IN THE FOURTEEN (14) PROVINCIAL GOVERNMENT HOSPITALS OF THE PROVINCE OF PANGASINAN

WHEREAS, the Integrated Hospital Operations and Management Information System (iHOMIS) is a computer-based information system developed by the Department of Health (DOH) to support the hospital management for effective and quality health care by providing timely, relevant and reliable information;

WHEREAS, the iHOMIS was developed as a reference model for electronic medical records and hospital information system that satisfies Philhealth requirements for electronic claims and DOH reporting necessities;

WHEREAS, implementation of the iHOMIS in the Province of Pangasinan would greatly help the fourteen (14) provincial government hospitals in their day-to-day operations to further improve their quality of management system and procedures within the hospital with Total Quality Management and Patient Safety as framework;

WHEREAS, the fourteen (14) provincial government hospitals of the Province have already undergone the iHOMIS/HBSys Training and are ready to implement the said information system;

WHEREAS, in collaboration with the DOH, the Province of Pangasinan fully supports this new technology to enhance health care, practice good governance and promote health services access for all Pangasinenses;


