APPROVING RESOLUTION NO. 2019-032 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) C.Y. 2019 OF SUAL, PANGASINAN AMOUNTING TO THREE HUNDRED SIXTY ONE MILLION ONE HUNDRED SIXTY THREE THOUSAND PESOS (P361,163,000.00)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2019-032 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Sual, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Local Development Council to the Sangguniang Bayan on July 4, 2019 thru MDC Resolution No. 01, S-2019 and was favorably acted upon by the Sangguniang Bayan on August 5, 2019 thru SB Resolution No. 2019-032;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-

> DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Sual, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development Disaster Risk Reduction (DRR) fund. c) Programs/Projects/Activities, d) Peace and Order Plan, e) Local Nutrition Action Plan, f) Activities in pursuance of the objectives of GAD, Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities of the LGU and Programs/Projects/Activities to Combat AIDS/HIV;

> WHEREAS, the proposed AIP of Sual for CY 2019 has an investment requirement of P361,163,000.00. Funding support for the implementation of which is embodied in their 2019 proposed Annual Budget, in the amount of P350,000,000.00 which was passed and approved by their Sangguniang Bayan on August 5, 2019 through Appropriation Ordinance No. 01. The remaining P11,163,000.00 is proposed for funding from external sources/national government agencies;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. More than twenty percent or about 35.75% of the LGUs IRA (P110,475,188.00) which is equivalent to P39,500,000.00 is allocated for development projects. The development projects proposed to be funded by 20% development fund were based on DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P17,500,000.00) is in conformity to Section 21 of RA 10121. The programs/projects/activities to be funded by 70% of the 5% LDDRM Fund in the amount of P12,250,000.00 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). However, the DRRM Plan shall still be submitted to the Office of the Civil Defense (OCD) for review as per Local Budget No. 77 dated May 15, 2018;

WHEREAS, the LGU of Sual had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the Provincial Planning and Development Office and was endorsed favorably to the Department of Interior and Local Government (DILG) Provincial Office for review and certification pursuant to the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";
