THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on January 17, 1997 at Lingayen, Pangasinan, the following resolution was approved:

PROVINCIAL ORDINANCE NO. 58-97

AN ORDINANCE DIVIDING BARANGAY NALSIAN OF CALASIAO, PANGASINAN INTO TWO (2) NEW, SEPARATE, DISTINCT AND INDEPENDENT BARANGAYS TO BE NAMED AS "BARANGAY NALSIAN NORTE" AND "NALSIAN SUR"

WHEREAS, the Sangguniang Panlalawigan is in receipt of Resolution No. 61, S-1994 of the Sangguniang Bayan of Calasiao requesting for the division or segregation of Barangay Nalsian into two (2) barangays to be known as "Nalsian Norte" and "Nalsian Sur";

WHEREAS, pursuant to Article 14 of the Implementing Rules and Regulations (IRR) of Republic Act 7160, otherwise known as the Local Government Code of 1991, creation of barangays by the Sangguniang Panlalawigan shall require prior recommendation by the Sangguniang Bayan;

WHEREAS, likewise, all the essential requirements therein have been satisfactorily met pursuant to Section Nos. 385 and 386 of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the residents and leaders of the subject barangay are of firm belief that the division of the same would hasten social, economic and political development in the area and would definitely foster faster and efficient delivery of basic services;

WHEREFORE, in view of the foregoing, on motion of SP Members Angel G. Baniqued and MacArthur C. Samson, Jr., duly seconded, be it enacted by the Sangguniang Panlalawigan in session assembled that:

Section 1. This Ordinance shall be known as "An Ordinance dividing Barangay Nalsian of Calasiao, Pangasinan into two (2) new, separate, distinct and independent barangays to be named as "Barangay Nalsian Norte" and "Barangay Nalsian Sur":

Section 2. The two (2) new and independent barangays shall have the following land area and boundaries as described below:

Barangay Nalsian Norte Land Area - 436,000 square meters

- N - Dagupan City Properties
- E - MacArthur Highway
- W - San Pablo River
- S - Nalsian Sur

Barangay Nalsian Sur Land Area - 1,568,000 square meters

- N - Barangay Nalsian Norte
- E - MacArthur Highway and W.A. Jones
- W - San Pablo River
- S - Poblacion West

Section 3. The expenses for the plebiscite to be conducted in the mother barangay shall be shouldered by the Municipality of Calasiao;

Section 4. The COMELEC shall conduct the plebiscite in the affected area of Calasiao, Pangasinan in accordance with law on March 16, 1997;
