**RESOLUTION NO. 581-2019**

**DECLARING ORDINANCE NO. 109, S-2019 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS AND PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES WITHIN THE TERRITORIAL JURISDICTION OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 109, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (3) (ii) of RA 7160; RA No. 7183, otherwise known as "An Act Regulating the Sale, Manufacture, Distribution and Use of Firecrackers and Other Pyrotechnic Devices; Executive Order No. 28, S-2017 and Memorandum Order No. 31, S-2018;

**WHEREAS**, subject ordinance shall take effect after the requirements of posting and publication are complied with by the Sangguniang Bayan pursuant to Section 59 (c) and 511 (a) of RA 7160;
