INVITING THE SCHOOLS DIVISION SUPERINTENDENTS OF PANGASINAN I, II, AND THE CITY SCHOOLS DIVISION SUPERINTENDENTS OF ALAMINOS, URDANETA AND SAN CARLOS TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS JULY 6, 2020 REGULAR SESSION TO APPRISE THE AUGUST BODY ON THE LEARNING CONTINUITY PLAN OF THE DEPARTMENT OF EDUCATION

WHEREAS, the COVID-19 pandemic and the implementation of different kinds of community quarantine in the country have greatly affected the educational system and have led the Department of Education to set the opening of the School Year 2020-2021 by August 24, 2020;

WHEREAS, SP Member Jeremy Agerico B. Rosario, as Chairman of the Committee on Education, has informed the Board of the readiness of one schools division in Pangasinan, and is hopeful of the same preparedness from the other schools divisions in the Province;

WHEREAS, the Department of Education is an active partner of the Provincial Government of Pangasinan in the promotion of its worthwhile plans and programs, and the Sangguniang Panlalawigan is desirous to hear from the schools divisions of Pangasinan about their continuity plan for education for School Year 2020-2021 as regards the changes in the curriculum and structure of education under the new normal;

WHEREAS, it is the intention of the Sangguniang Panlalawigan to support the Learning Continuity Plans of the schools divisions in Pangasinan aimed toward ensuring continuity of quality education amidst the challenges of COVID-19 pandemic;
