APPROVING RESOLUTION NO. 20, S-2019 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE LIST OF THE PROPOSED PROJECTS UNDER TOBACCO EXCISE TAX 2016 OF THE MUNICIPALITY OF VILLASIS, PANGASINAN AS ADDITIONAL REQUIREMENT OF THE DEPARTMENT OF BUDGET AND MANAGEMENT”

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 20, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Sangguniang Bayan Resolution No. 20, S-2019 approving the list of proposed projects to be funded from the LGUs share from the FY 2016 collection from burley tobacco excise tax is one of the requirements to be submitted by the LGU to the Department of Budget and Management;

WHEREAS, the said list of proposed projects was already embodied in the municipality’s Supplemental Investment Program which was endorsed by Local Development Council of Villasis thru MDC Resolution No. 01-2019 dated August 5, 2019 and approved by the Sangguniang Bayan thru Resolution No. 19, S-2019 dated August 30, 2019;




