AUTHORIZING THE TURNOVER OF THE COMPLETED MULTI-PURPOSE BUILDING OF THE DEPARTMENT OF EDUCATION-SCHOOLS DIVISION OFFICE OF SAN CARLOS CITY, PANGASINAN FUNDED UNDER THE SPECIAL EDUCATION FUND OF THE PROVINCE

WHEREAS, the Provincial Government of Pangasinan recognizes the need for a better and quality service of education to the people especially for the learners;

WHEREAS, the Provincial Government of Pangasinan has allotted a budget for the construction of a 2-storey multi-purpose building which was funded under the Special Education Fund with a total cost of P14,651,025.32;

WHEREAS, the said building was constructed in CY 2018-2019 for Phase I and CY 2020-2021 for Phase II;

WHEREAS, as of today, the above-mentioned asset is still listed in the books of accounts of the Provincial Government therefore, there is now a need to formally turn over the said building to the DepEd for the maintenance of the same;

WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the turnover of the completed multi-purpose building of the Department of Education-Schools Division Office of San Carlos City, Pangasinan funded under the Special Education Fund of the Province;


