PROVINCIAL RESOLUTION NO. 606-2021

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO A DEED OF USUFRUCT WITH THE NATIONAL FOOD AUTHORITY (NFA) OVER A PARCEL OF LAND CONTAINING AN AREA OF SEVEN HUNDRED (700) SQUARE METERS, MORE OR LESS, WHERE THE NFA PROVINCIAL OFFICE BUILDING HAS BEEN ERECTED

WHEREAS, Resolution No. 358-96, approved by the Sangguniang Panlalawigan on September 6, 1996, authorized the Provincial Governor to Enter into a Deed of Usufruct with the National Food Authority, Granting the Latter the Right to Use a 700 Square Meter Provincial Lot as Site of NFA's Provincial Office Building;

WHEREAS, a Deed of Usufruct, dated March 10, 1997, was then entered into by and between Pangasinan (represented by former Honorable Governor Oscar M. Orbos) and NFA (represented by its Administrator, Joenari D. Gerochi);

WHEREAS, the Deed of Usufruct executed by the Province and the NFA will already expire on March 2022;

WHEREAS, the Province, recognizing the significant role of the NFA in ensuring food security and the stability of supply and price of rice, hereby agrees to allow the use of the aforementioned property by way of usufruct to the latter;

WHEREAS, the term of the usufruct shall be for a period of twenty-five (25) years, subject to early termination for just and valid cause, or renewable upon mutual consent and discretion of both parties;


WHEREAS, there is a need for the Sangguniang Panlalawigan to authorize the Provincial Governor, Amado I. Espino III, to enter into a Deed of Usufruct with the National Food Authority, represented by Ms. Judy Carol L. Dansal, Administrator, granting the latter the right use of the property;

WHEREFORE, in view of the foregoing, on motion of SP Members Liberato Z. Villegas and Noel C. Bince, duly seconded, it was –


