AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE TO BE USED BY THE PROVINCIAL HEALTH OFFICE

WHEREAS, the Provincial Government of Pangasinan is in need of a vehicle which shall be used for the mobile health caravan operations in the different localities of the Province:

WHEREAS, the vehicle shall be used primarily by the Provincial Health Office which supervises the "I Love Pangasinan Kalusugan Karavan", a flagship health program of the Province that aims to bring health services at the barangay level of every city and municipality;

**WHEREAS,** the Provincial Government of Pangasinan intends to buy one (1) unit of motor vehicle with a total amount of P1,110,760.00 to be charged to the Provincial Health Office - Capital Outlay (4411) fund, with the following specifications:
