### PROVINCIAL RESOLUTION NO. 625-2019

AUTHORIZING GOVERNOR AMADO I. ESPINO III TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH LAND BANK OF THE PHILIPPINES-LINGAYEN BRANCH FOR THE IMPLEMENTATION OF THE ELECTRONIC SALARY LOAN (ESL)

WHEREAS, the Provincial Government of Pangasinan is in receipt of a letter dated September 27, 2019 from Land Bank of the Philippines (LBP)-Lingayen Branch introducing to the Province another innovation on their Salary Loan Program which is called Electronic Salary Loan (ESL);

WHEREAS, last March 10, 2014, the Sangguniang Panlalawigan has approved Provincial Resolution No. 144-2014 Authorizing Governor Amado T. Espino, Jr. to enter into a Memorandum of Agreement (MOA) with Land Bank of the Philippines-Lingayen Branch for the implementation of the Land Bank Mobile Loan-Saver (LMLS) Facility Through the Savings and Salary Loan System (SSLS);

WHEREAS, the revised features and latest innovation of the Salary Loan Program of the Land Bank of the Philippines is an extension of its Livelihood Loan Facility to qualified officials, officers and employees of the Provincial Government of Pangasinan;
