WHEREAS, one of the respected local leaders of the Province of Pangasinan, Honorable Amadeo R. Perez, Jr., peacefully joined his Creator last June 25, 2020 at the age of 83 due to a lingering illness;

WHEREAS, the late former Mayor and Congressman Amadeo R. Perez, Jr. was the longest-serving Mayor of the City of Urdaneta from 1966-1968, 1980-1986, and his last three terms were from 1988-1992, where he introduced a host of noteworthy projects which led to the progress and development of the city;

WHEREAS, the late former Mayor and Congressman Amadeo R. Perez, Jr. had capably served the 5th Congressional District of Pangasinan as Congressman for three consecutive terms from 1992-1995, 1995-1998 and 1998-2001, and had again served the City of Urdaneta as Local Chief Executive from 2001-2010;

WHEREAS, during the celebration of the 432nd Agew na Pangasinan in April 11, 2012, the late former Mayor and Congressman Amadeo R. Perez, Jr. had also been conferred the ASNA Award for having been an inspiration and a role model to fellow kabaleyans and the Filipino people in the field of Government Service-Public Administration;

WHEREAS, the late former Mayor and Congressman Amadeo R. Perez, Jr. had also served as Chairman of the Manila Economic and Cultural Office during the term of President Benigno Aquino III from 2010 to 2016 where he had been an efficient and effective leader in the promotion of Philippine Trade, investments, tourism, labor and scientific and cultural cooperation with Taiwan in coordination with Philippine government agencies and the private sectors;
