APPROVING RESOLUTION NO. 109, S-2018 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2018”

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 109, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Calasiao, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program for CY 2018. This was endorsed by the Council through MDC Resolution No. 07, S-2018 dated October 26, 2018 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 109, S-2018 dated November 7, 2018;

WHEREAS, said Supplemental Annual Investment Program which has a total investment requirement of P5,867,980.05 covers the augmentation fund for personal services and maintenance and other operating expenses of some offices of the municipality as well as to supplement the 5% MDRRMF and 5% GAD of the LGU;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
