#### **PROVINCIAL RESOLUTION NO. 638-2019**

APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020

**WHEREAS,** presented for consideration by the Sangguniang Panlalawigan is the Annual Investment Program (AIP) of the Province of Pangasinan for CY 2020 as endorsed by the Provincial Development Council thru PDC Resolution No. 01, S-2019;

WHEREAS, local government units are mandated to have their respective comprehensive multi-sectoral development plans to be initiated by its local development councils pursuant to Sections 106 and 109 of RA 7160;

WHEREAS, the AIP of the Province for CY 2020 is an expression of the Comprehensive Development Plan of the Province, implementation and funding of which shall emanate from the national, provincial, and other external sources;

**WHEREAS,** a total amount of P25,596,919,544.00 is required to finance the full implementation of the various programs and projects in the said AIP of the Province for CY 2020, broken down as follows:

General Public Services - P 1,558,474,674.00 Social Services - 2,765,716,440.00

Economic Development - 21,272,728,430.00

**WHEREAS,** of the above total financial requirement, fund sources shall come from the following:

National Government - P21,140,505,324.00 Provincial Government - 4,456,414,220.00
