RESOLUTION NO. 641-2020

DECLARING ORDINANCE NO. 20-01 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED “MANDATORY WEARING OF FACE MASK FOR PROTECTION AGAINST COVID-19 INFECTION IN THE MUNICIPALITY OF STA. MARIA, PANGASINAN, AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Ordinance No. 20-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places); Section 8, General Provisions of the Omnibus Guidelines on the Implementation of Community Quarantine; and Section 18 of Executive Order No. 0033-2020 (Implementing Guidelines on Modified General Community Quarantine in the Province of Pangasinan);

WHEREAS, however, the Sangguniang Bayan shall consider the observation of the Provincial Legal Officer in her opinion dated June 18, 2020;
