APPROVING RESOLUTION NO. 23, S-2020 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 1, CY 2020 IN THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 23, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Mapandan, Pangasinan prepared the Supplemental Annual Investment Program No. 1 for CY 2020 in response to the COVID-19 crisis. This was endorsed by the Council, through MDC Resolution No. 01, S-2020 dated May 27, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 23, S-2020 dated June 8, 2020;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P9,240,285.00 covers programs, projects and activities intended to address the COVID-19 emergency/pandemic;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
