APPROVING RESOLUTION NO. 2017-208-134 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 FOR THE CALENDAR YEAR 2017 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2017-208-134 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality’s Supplemental Investment Program No. 5 covering projects to be funded by LGUs share from FY 2014 collection of Burley Tobacco Excise Tax in the amount of P25,223,673.00. This was endorsed thru MDC Resolution No. 7, S-2017 dated October 18, 2017 and was subsequently approved by their Sangguniang Bayan through Resolution No. 2017-208-134 dated October 30, 2017. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the identified projects, Construction of Day Care Center in Barangay San Marcelino, Barangay Health Station in San Aurelio 1st and Concreting of Farm-to-Market Road are not included in the municipality's 2017 approved Annual and Supplemental Investment Programs;

WHEREAS, further, the proposed projects conforms with Local Budget Memorandum No. 76 dated October 6, 2017 (Guidelines on the Release and Utilization of the Shares of Local Government Units (LGUs) from the Collections of Excise Tax on Locally Manufactured Virginia-Typed Cigarettes under Republic Act No. 7171 and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the Allocation of LGUs under the FY 2016 General Appropriations Act (GAA), RA No. 10717, Continuing Appropriations and FY 2017 GAA, RA No. 10924);


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
