RESOLUTION NO. 65-2022

DECLARING MUNICIPAL ORDINANCE NO. 10, S-2021 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF ONE HUNDRED TEN MILLION PESOS (P110,000,000.00) TO FUND THE SAN FABIAN COMMERCIAL COMPLEX LOCATED AT BARANGAY CAYANGAN, SAN FABIAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Municipal Ordinance No. 10, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Provincial Accountant have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 22 (a) (5) (c), 296 (a) and (b), 297 (a) (b) and (c) and 444 (b) (vi) of R.A. No. 7160;

WHEREAS, the LGU-San Fabian shall observe that the subject ordinance must be pursued in line with the provisions of the Local Government Code of 1991 which mandates that every loan application mustcomply with the requirements of the Department of Finance, the Bureau of Local Government Finance Circular No. 1-2012 and the Bankko Sentral ng Pilipinas Circular No. 769, S-2012;
