APPROVING RESOLUTION NO. 2020-27 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2020-01 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2020-27 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binalonan, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Investment Plan No. 2020-01 through MDC Executive Committee Resolution No. 1, S-2020 dated April 13, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on April 20, 2020 through Resolution No. 2020-27. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Investment Plan No. 02 with an investment requirement amounting to P12,196,727.00 covers programs, projects and activities intended to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan To Heal As One Act);

WHEREAS, on April 20, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 1 through Appropriation Ordinance No. 2020-01 to support the implementation of the Supplemental Investment Program of the municipality;
