APPROVING RESOLUTION NO. 40, S-2019 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 6 FOR CY 2019 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P5,123,943.37"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 40, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Fabian, Pangasinan has prepared the municipality's Supplemental Annual Investment Program No. 6 for Calendar Year 2019 and endorsed by the Council thru MDC Resolution No. 07, S-2019 dated July 8, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through SB Resolution No. 40, S-2019 dated September 11, 2019;

WHEREAS, the Supplemental Annual Investment Program No. 6 of the municipality with an investment requirement of P5,123,943.37 covers fund augmentation for the personal services, maintenance and other operating expenses and other development projects;
