#### PROVINCIAL RESOLUTION NO. 663-2020

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO SIGN THE DEED OF DONATION AND RECEIVE THREE (3) UNITS OF AMBULANCE FROM THE DEPARTMENT OF HEALTH (DOH)

**WHEREAS,** one of the primordial concerns of the provincial government of Pangasinan is to address health issues and provide medical service needs of the people;

WHEREAS, the Department of Health (DOH), as the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities of local government units, has manifested its desire to further augment its support to the Provincial Government of Pangasinan through its fund under the Health Facility Enhancement Program for CY-2019;

**WHEREAS**, the Province of Pangasinan will be the recipient of three (3) units of newly-equipped ambulance from the Department of Health Office in the form of a donation and hereby expresses its willingness to accept the same;

WHEREAS, these ambulances can be used primarily and effectively by the Province through the Urdaneta District Hospital, Western Pangasinan District Hospital and Dasol Community Hospital to cater and respond immediately to the health necessities of the people especially in times of emergencies;

**WHEREAS,** it is to the best interest of the provincial government to sign the Deed of Donation and accept the ambulance from the DOH to augment the need for medical service vehicles of the Province;
