#### RESOLUTION NO. 665-2020

APPROVING SB RESOLUTION NO. 18, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 01 CY 2020 OF THE MUNICIPALITY OF BANI, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 18, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020, endorsed to the Sangguniang Bayan for approval on March 16, 2020 by the MDC thru Resolution No. 2020-02 and was favorably acted upon by the Sangguniang Bayan on May 14, 2020 thru SB Resolution No. 18, S-2020;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the personal services and maintenance and other operating expenses of municipal offices and implementation of development projects, gender and development activities, and local disaster risk reduction programs and projects/activities;

**WHEREAS,** however, with reference to local disaster risk reduction and management program, the LGU shall set aside 30% LDRRMF in lumpsum appropriation for Quick Response Fund as per Section 4 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;

WHEREAS, the said Supplemental Investment Program No. 1 also includes development programs/projects proposed to be funded from the realigned 20% development fund from CYs 2016, 2017, 2018 and 2019 in the amount of of P4,872,013.60. Said realignment was endorsed by the Municipal Development Council thru MDC Resolution No. 2020-01 dated March 16, 2020;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P15,192,586.06. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01 which was approved by the Sangguniang Bayan on May 14, 2020 thru Appropriation Ordinance No. 02, S-2020 and approved by the Municipal Mayor on June 2, 2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
