RESOLUTION NO. 684-2020

APPROVING RESOLUTION NO. 60, S-2019-22 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2020 OF THE CITY OF URDANETA"

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 60, Series of 2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Urdaneta City, Pangasinan has formulated the city's Annual Investment Program for CY 2020 and endorsed thru CDC Resolution No. 5-2019 dated September 16, 2019 to the Sangguniang Panlungsod for approval. This was subsequently approved by their Sangguniang Panlungsod thru Resolution No. 60, S-2019-22 dated October 8, 2019. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the city is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Urdaneta City, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the city. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, Municipal Nutrition Action Plan, and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP of Urdaneta City has a total investment requirement amounting to P1,336,874,491.05. Of this, P1,328,374,491.05 will be funded by the city's 2020 Annual Budget which was passed and approved by their Sangguniang Panlungsod through Appropriation Ordinance No. 5, S-2019-22 dated October 29, 2019 while the remaining amount of P8,500,000.00 will be funded from the DRRMF Trust Fund. It also includes projects proposed to be funded by external fund sources;

WHEREAS, the development fund amounting to P119,500,000.00 which is allocated for development projects is twenty percent (20%) of the city's IRA (P595,342,358.00) for CY 2020. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs, projects and activities of the 5% LDRRM Fund of the city amounting to P63,663,551.44 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). **However, the LDRRM Plan shall be submitted by the city to the Office of Civil Defense (OCD) for review as provided under Item No. 2.2.12 of the Department of Budget and Management as per Local Budget Memorandum No. 77 dated May 15, 2018;**

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan of the city was already reviewed by the Department of Interior and Local Government (DILG) and found to be fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated March 21, 2019;


